

## PRIVACY POLICY

(Last Revised Jan. 5, 2019)

mPower6, LLC, a South Carolina limited liability company (hereinafter, "mP6") Privacy Policy (this "Privacy Policy")

We do not sell, trade, or otherwise transfer to outside individual, entities, or parties your personally identifiable information.

The user information that you input or disclose in the use of our products and services will never be sold or shared in any way to any third-party website for any reason whatsoever.

### ***What types of information do we collect?***

We collect information from you when you register on our website or when you register over the phone or in-person for our services. When registering, as appropriate, you may be asked to enter all of your personally identifiable information including, but not necessarily limited to, name, email address, mailing address, phone number, and/or or credit card information. You may, however, visit our site anonymously.

### ***What do we use your information for?***

Any of the information we collect from you may be used in one or more of the following ways:

- to process transactions;
- to send periodic emails or texts; and/or
- your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the expressed purpose of delivering the purchased product or service requested

The email address you provide for order processing will only be used to send you information and updates. Aside from the above- or below-stated purposes, no emails are sent without your authorization.

### ***How do we protect your information?***

We implement a variety of security measures to maintain the safety of your personal information when you place an order or access your personal information.

We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our payment gateway providers database only to be accessible by those authorized with special access rights to such systems and who are required to keep the information confidential.

After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. Your information will never be sold or shared in any way to any third party website for any reason whatsoever.

There is basic information that you may transmit via third-parties who assist us in operating our website, conducting our business, or servicing you. This only applies to actions you take by utilizing the share functionality that post information on various email or social media platforms, with your permission, such as Facebook®. No other information that is ever stored about you is shared with any third parties.

**For Example:** If you choose to utilize the share functionality of our website to send messages via Facebook®, you are governed by Facebook's® privacy policy for such sharing functions and actions on their website. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect our or other's rights, property, or safety.

Notwithstanding the foregoing, you understand that your image, name, and/or other limited personal information may be shared on one or more websites or advertisements of or for the charity or service project or organization your team or group has elected to support along with your fundraising efforts.

### ***Third-Party links***

Occasionally, at our discretion, we may include or offer third-party products or services on our website. These third-party sites have separate and independent privacy policies. We therefore have no responsibility or liability for the content and activities of these linked sites. Nonetheless, we seek to protect the integrity of our site and welcome any feedback about these sites. This applies to any links that a user may click that redirects the user to another website. This is currently not utilized by mP6 in any manner.

### ***Children's Online Privacy Protection Act Compliance***

Your privacy is important to us, and we recognize the need to provide additional privacy protection for underage persons using the mP6 internet-based services (our "Services"). Our privacy practices are guided by the United States' Children's Online Privacy Protection Act of 1998 ("COPPA"), as well as other data privacy laws of the United States and other applicable countries.
